Terms and Conditions

1. General

Adventure travel is not conventional travel; it is understood that the services and standards offered by New Frontiers Adventure Tours, C.A. (NFAT) on its tour packages are not the same as the ones one receive back home. The adventurous nature of the tours also involves a significant amount of personal risk, you must acknowledge that fact and you are responsible for selecting a tour suitable to your health, physical abilities and interests. Please take a few moments to read and understand the following conditions that will bind the Customer and New Frontiers Adventure Tours upon purchase of the tour package. Acceptance of this contract occurs when deposit is received by NFAT at its office.

2. Reservations and Payment

To reserve space on any program, a non-refundable deposit of \$200 is required, accompanied by the completed and signed Reservation Form. The balance of the tour price is due 60 days prior to departure. If the balance is not paid in time, NFAT reserves the right to treat the reservation as canceled. Reservations made 60 days or less before the departure require full payment at the time of the reservation.

3. Cancellation

Any cancellation by a Customer must be made in writing. The following fees will be charged: More than 60 days before departure: \$200; 14 to 59 days before departure: 50% of trip cost; less than 14 days before departure: 100% of trip cost. We strongly advise you to purchase cancellation insurance soon after booking for a trip, as this will cover non-refundable cancellation costs in certain circumstances.

4. Prices

Prices include accommodation, transportation, equipment, and services of a bilingual guide, as described in the itinerary.

Prices do not include international flights, airport transfers (unless otherwise noted), charge for passports, visas, vaccinations, departure taxes and excess baggage, insurance of any kind, optional tours, and items of a personal nature.

Until full payment is received, prices are subject to change due to unfavorable exchange rates fluctuations, increases in air fares or other transportation costs, or government actions, or other factors beyond NFAT's control. If a surcharge results in an increase of more than 10% of the tour cost, the Customer may cancel the booking within 14 days of the notification of the sur-

charge and obtain a full refund.

5. Changes

This type of travel requires considerable flexibility and should allow for alternatives. It is understood that NFAT can change the route, schedules, itineraries, amenities, modes of transport due to local circumstances or events, like sickness, mechanical failures, flight cancellations, strikes, political problems, climate or other unpredictable or unforeseen able circumstances. NFAT reserves the right to cancel any trip due to inadequate sign-up which makes the trip economically unfeasible to operate. In such cases, the Customer is entitled to a full refund or may choose any alternative tour offered by NFAT.

6. Insurance

The Customer is responsible to take sufficient travel insurance covering personal accident, medical expenses, air ambulance, loss of effects, repatriation costs and all other expenses which might arise as a result of loss, damage, injury, delay or inconvenience; it is recommended to make sure that the insurer is aware of the type of travel to be undertaken.

7. Release

Customers, group organizers, travelers and tour participants, individually and jointly, release NFAT from any and all liability and responsibility, known or unknown, present or future, for any and all loss, injury to person, damage to property, or accident, or which may be the result of any delay or change of itinerary, or which may be occasioned through acts of any company and/or persons engaged in carrying out the arrangements connected with the tour package purchased or otherwise in connection herewith, which is beyond its control, including but not limited to, acts of God, transportation problems, government actions, wars, civil disturbances, labor disputes, quarantine, theft, force Majeure, sickness, weather, accident by aircraft, boat, motor vehicle or any other form of transport or in any hotel, guest house, pension or other form of accommodation and that includes all all expenses or damages, direct or consequential, claimed or sustained by customers and and waive NFAT based on any claim of negligence by any of the suppliers of services included in the tour package. Payment of deposit is taken in acknowledgement and agreement of the above items.
